Debswana invites suitably qualified and experienced HDPE manufacturing Companies with a traceable track record in HDPE processing and/or recycling to undertake **BUYING AND RECYLING OF HDPE SCRAP MATERIAL AT ORAPA NO.1 PLANT AND LETLHAKANE OLD PLANT FOR DEBSWANA**. Only Companies who can demonstrate experience, capacity and capability in provision of services of a similar nature and scale are invited to tender. Companies should demonstrate capability to process the scrap HDPE locally (in Botswana) in support of circular economy.

**Companies should have a functional HDPE processing or manufacturing facility locally for their interests to be considered.**

Only Contractors who can demonstrate experience and capacity to handle and process the scrap HDPE from the two (2) Plants (Orapa No.1 Plant and the Letlhakane Mine Processing Plant) **locally** are invited to tender.
