



Suitably qualified and experienced Companies are hereby invited to submit an Expression of Interest (EOI) for the following project for Debswana Diamond Company (Pty) Ltd:

DOC1530633638 – EXPRESSION OF INTEREST (DESIGN, BUILD, OPERATE, AND MAINTAIN STAFF HOUSING IN JWANENG TOWNSHIP)

1. BRIEF

Debswana Diamond Company (Pty) Ltd, through its Jwaneng Underground Project, invites suitably qualified and experienced property developers, financial institutions, and/or pension funds to submit Expressions of Interest (EOI) for the **design, financing, construction, operation, and maintenance** of residential staff housing in Jwaneng Township, Botswana.

This housing initiative is in response to projected accommodation demands associated with the mine's transition from open pit to underground operations and aims to provide quality living solutions for employees and strategic partners.

2. SCOPE OF WORK

The proposed development comprises **35 residential units** on Debswana-owned, fully serviced plots ranging in size from **498 m² to 1600 m²**, located within Jwaneng Township. The required units are as follows:

- 2 Executive Houses
- 18 High-Cost Houses
- 15 Medium-Cost Houses

The residential units will be leased for an initial term of **15 years**, with an option to extend for an additional **5 years**.



3. MINIMUM DESIGN REQUIREMENTS

Each housing category must, at a minimum, meet the following specifications:

- **Medium-Cost Houses**: 3 bedrooms (one en-suite), study, lounge, maid's quarters, single garage, solar water heating, and smart water/electricity metering.
- High-Cost Houses: 3 bedrooms (one en-suite), guest toilet, dining room, double garage, solar and electric water heating, boundary wall.
- **Executive Houses**: 4 bedrooms, swimming pool, electric fencing, intrusion alarms, CCTV provision, double garage and carport, air conditioning throughout.

Detailed design specifications, including finishes, kitchen appliances, security provisions, and entertainment areas, are provided in the full Scope of Work (SOW).

4. SPECIFIC REQUIREMENTS

Interested parties must demonstrate:

- **Technical Capability**: Proven ability to undertake full DBOM (Design, Build, Operate, Maintain) projects, including post-construction property management (rent collection, utilities, maintenance, municipal obligations).
- Financial Capability:
- Demonstrated ability to finance real estate projects of similar nature and complexity, with a minimum project value exceeding BWP 20 million.
 - Evidence of available funding sources such as:
 - Proof of own funds
 - Letters of credit or financing from reputable institutions
 - o Letters of good standing from financial institutions
- **Relevant Experience**: Successful completion of comparable residential developments, incorporating sustainability standards (e.g., Green Star, Green Building Council).
- **Project Planning:** A clear project execution plan supported by organizational structure, decisionmaking hierarchy, and reporting mechanisms.
- **Regulatory Compliance**: Adherence to the Buildings Development Control Code and all relevant permitting requirements (e.g., Department of Environmental Protection, BERA).
- **Rental Proposal**: Pricing structure per unit type, rental escalation model, and a full cost breakdown (including profit margins, financing costs, taxes, overheads, etc.).



5. EVALUATION CRITERIA

EOI submissions will be assessed based on the following weighted criteria:

- Financial Capacity (30%): Demonstrated ability to finance large-scale real estate projects.
 - Evidence of having completed projects of similar nature value at more than BWP 20 million
 - Availability of funding sources, including;
 - Proof of own funds
 - Letters of good standing from financial institutions
- Organizational Capacity (20%): Adequate personnel and project execution structure.
- Project Management Methodology (15%): Clear execution strategy and timelines.
- Experience (20%): Previous successful project delivery in similar developments.
- Quality Assurance (15%): Comprehensive QA/QC plan for project execution.

6. SUBMISSION GUIDELINES

Interested companies must submit an Expression of Interest including the following documentation:

- 1. Detailed company profile highlighting technical and financial capabilities
- 2. Audited financial statements for the most recent fiscal year
- 3. Curriculum vitae and professional certifications of key personnel
- 4. Organizational structure and proposed project methodology
- 5. Minimum of three references for similar completed projects
- 6. Comprehensive Quality Assurance and Quality Control (QA/QC) plan
- 7. Detailed rental pricing proposal, including full cost breakdown
