### 1.0 BRIEF AND SCOPE OF SERVICES

Debswana Diamond Company requires 100% citizen owned companies with reputation and experience in drilling to provide down-the-hole (DTH) pre-split and perimeter (trim) drilling services at Jwaneng Mine, Botswana. The services are intended to support slope stability and highwall control in the Cut 8 and Cut 9 mining areas.

Bidders are required to propose 2 equipment option as follows:

- 1. Fully Automated Drilling Solution: this option must deploy fully autonomous drilling equipment. the equipment must demonstrate full autonomous functionality, including autonomous tramming, collaring, drill string handling, drill-to-target execution, and live telemetry integration with the mine's control centre. The proposed systems must ensure high precision, repeatability, safety, and productivity under varying pit conditions.
- 2. Manual Drilling system: Debswana owns autonomous drilling hardware. This option must deploy a conventional drilling system, capable of being retrofitted with Debswana's existing autonomous hardware. Bidders must ensure compatibility with autonomous drilling hardware provided by Epiroc or Sandvik which Debswana already owns. This hardware will be issued free of charge to the successful Contractor and must be returned to the Mine upon contract completion
