## 1.0 BRIEF AND SCOPE OF SERVICES

Debswana Diamond Company wishes to source and engage a service provider who will perform provision of contractor medical surveillance services for Jwaneng Mine contractors and subcontractors. The successful provider shall be required to ensure the following minimum service to be rendered in terms of the provision of the risk-based contractor's medical surveillance service

- 1. Performing pre-employment, periodic, ad-hoc, and exit medical assessments as per similar exposure group (SEG) that include:
  - a) General Health Questionnaires
  - b) General Medical Examination
  - c) Objective tests: Chest x-ray, Spirometry, Audiometry, Vision Assessment, Electrocardiogram (ECG), Physical Ability Assessment, Drug and Alcohol testing.
  - d) Any other risk-based assessments mandated by the SEG i.e. full blood count (FBC) for radiation workers, biological effect monitoring etc.
- 2. Keeping and maintaining occupational health records as per Occupational health standards/ policy and the national legal framework.
- 3. Keeping and maintaining and sharing all relevant statistics for reporting and data-driven decisionmaking.
- 4. Assist with identification and response to disease outbreaks as guided by Debswana
- 5. Align with and participate in relevant international standards of care such as ISO 45001; ISO 14001; ISO 45003 and COHSASA.
