Brief and Scope of Servives

The Jwaneng Mine is operated by Debswana Diamond Company and is governed by both corporate standards and Botswana legislation, including the Mine, Quarries, Works and Machinery Act (MQWMA). The company requires reliable heavy-lift crane services to execute specialized lifting tasks within workshops, plant areas, and pit operations. Mobile cranes with 180t and 220t capacity will be hired when required to ensure operational flexibility, safety, and compliance with statutory requirements. Failure to secure reliable crane services poses operational downtime, safety risks, and delays to critical maintenance activities

The Scope of Work include includes but is not limited to the following:

- Hire of mobile cranes with lifting capacities of 180t and 220t
- Provision of certified crane operators.
- Supply of all required lifting accessories where applicable. (Provide indicative list with response)
- Mobilization and demobilization of cranes from Jwaneng Mine.
- Execution and the compliance thereof lift in accordance with approved lift Plans and risk assessments.
- Compliance with MQWMA, Debswana SHE standards, and OEM requirements.
- Submission of inspection certificates, operator licenses, and service records.
